I am requesting funding for the Kennedy Outpatient Center in fiscal year 2022. The entity to receive funding for this project is Erlanger Health System, located at 975 E 3rd St. Chattanooga, TN 37403. The funding would be used to support an 11,000 SF build out of a pediatric MRI, three procedural rooms and a post anesthesia care unit at the outpatient center. Over 40% of Kennedy's pediatric patients are Medicaid, CHIP and uninsured. These services are in shortage and critically needed in the greater Chattanooga Region. Using inpatient procedure suites and adult MRI systems is medically inappropriate, inconvenient, unnecessarily costly and results in delayed care. There is an economy of scale to having both the MRI and outpatient surgical facilities in the same area, functioning together, as this allows the same pre- and post-procedure staff to safely serve the volume of children who would be coming through both areas on a daily basis.
